1) Minutes of previous meeting

The minutes of the Committee Meeting held on 10^{th} January 2019 were approved as an accurate summary of the proceedings.

2) <u>Secretary's Report</u>

Adult membership renewals have gone well with the club attracting new members as well as a significant decrease in juniors due to departure of Kenny Martin's Olcote Academy.

3) Treasurers Report

- £13,417, £20,026 cash reserve, Total £33,589 (grants £9431k & £16k, expecting approx. further £3k)
 - Huge thanks to the Steve Birss for tracking down and accessing the grants that have kept the club afloat during this difficult time
- Income difference from lost fees (lights and subs) is equivalent to grants.
- Membership fees and lights are significantly down on previous years due to being closed for COVID (per government requirements)
- Accounting process improved to use accounting package (Zero, for £10 / month) allows projections/reports and more accurate real-time accounting.
 - Thanks to Paul Watson for donating the first year's costs and assisting in uploading the historic data as well as all the accounting advice and assistance he continues to provide the club for free.

- Vote taken on the maximum value it's possible for the chairman to unilaterally sign-off, unanimously agreed to be £500

7) <u>Capital Investment and Maintenance Programme</u>

- Changing rooms now cubicled (6 off, £4k costs)
- Roof side panel needs replacing awaiting contractors
- Electrical and gas supplies into the club:
 - It has been identified that the gas supply is insufficient for the energy requirements of appliances in the club, a larger pipe is required to supply the clubs requirements
 - The electrical meter is currently located within Ferriby Hall (within Medici's) and the club can only access when Medici's is open; which is sporadic. It is proposed that the meter is relocated within the club, so that no-one can accidentally cut the club off.
 - Richard Brown to investigate the costs associated with such alterations costs circa £6.5k (estimate from Feb 2020)
